# Post-truth and the COVID 19 Truce: Reflections on the Pandemic and Media Constructivism

We can no longer think of ourselves as the centre of the world, we can no longer believe that we are invincible, and we can no longer underestimate the destructive power of even the smallest things-like a virus.

The concept of post-truth has in the recent past been an object of constant deliberation and public debate.
