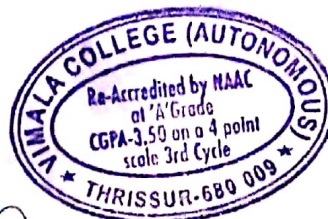

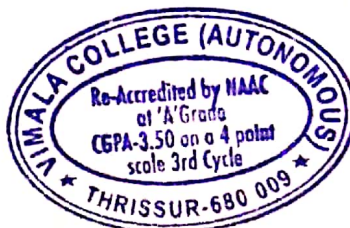


1. **Parties.** This Memorandum of Understanding (herein after referred to as "MOU") is made and entered into by and between Alpha Palliative Care, whose address is Alpha Palliative Care, Thrissur Hospice, Pottayil Lane, Thrissur, Kerala-680004 and the Vimala College (Autonomous), Thrissur, whose address is Vimala College (Autonomous), Thrissur, Kerala-680009

2 **Purpose.** The purpose of this MOU is to establish the terms and conditions under which the PAALANAM, a Students Initiative Palliative Care of Vimala College (Autonomous) Thrissur, will provide volunteers to Alpha Palliative Care (Eight volunteers from the date the MOU is being mutually signed and agreed upon).

3 **Term of MOU.** This MOU is at-will and may be modified by mutual consent of authorized officials from Alpha Palliative Care, whose address is Alpha Palliative Care, Thrissur Hospice, Pottayil Lane, Pothole, Thrissur, Kerala, 680004 and the Vimala College (Autonomous) ,Thrissur ,whose address is Vimala College (Autonomous) Thrissur, Kerala, 680009 .This MOU shall become effective from 15 January 2020 upon signature by the authorized officials from the Alpha Palliative Care, whose address is Alpha Palliative Care, Thrissur Hospice, Pottayil Lane, Poothole, Thrissur, Kerala 680004 and the Vimala College (Autonomous) Thrissur, whose address is Vimala College (Autonomous)Thrissur, Kerala -680009 and will remain in effect until modified or terminated by the any one of the partners by the mutual consent. In the absence of mutual agreement for the renewal of the same by the authorized officials from the Alpha Palliative Care, whose address is Alpha Palliative Care, Thrissur Hospice, Pottayil Lane, Poothole, Thrissur, Kerala, 680004 and the Vimala College (Autonomous) Thrissur, whose address is Vimala College (Autonomous) Thrissur, Kerala- 680009. This MOU shall end on 15 January 2021.

- Ensure the volunteers' safety and all the expenses incurred for the home visit shall be beared by Alpha Palliative Care
- Provide transportation facility to the volunteers to the designated places where the organization want them to be
- Ensure that volunteers are being allocated only as a supportive person for the counseling.

- Provide eight volunteers to Alpha Palliative Care

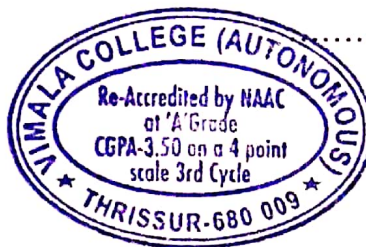
6. **General Provisions**

A. **Amendments.** Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.

B. **Third Party Beneficiary Rights.** The parties do not intend to create in any other individual or entity the status of a third party beneficiary, and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained in this MOU shall operate only between the parties to this MOU, and shall inure solely to the benefit of the parties to this MOU. The provisions of this MOU are intended only to assist the parties in determining and performing their obligations under this MOU. The parties to this MOU intend and expressly agree that only parties signatory to this MOU shall have any legal or equitable right to seek to enforce this MOU, to seek any remedy arising out of a party's performance of failure to perform any term or condition of this MOU, or to bring an action for the breach of this MOU.
