



# MEMORANDUM OF UNDERSTANDING (MOU)

This agreement is entered into at Amal Jyothi College of Engineering Kanjirappally, Kerala, India on this day of ...4. MAL 2021 ("Effective Date")

## Between

Amal Jyothi College of Engineering Kanjirappally, Kerala, India represented by Dr. Z. V Lakaparampil (Principal) of the **one part** 

## AND

Vimala College (Autonomous) Thrissur, Kerala, India represented by Dr. Sr. Beena Jose (Principal) of the **One Part**;

# Art. 1 Cooperation

The purpose of this agreement is to formally express the mutual wish of Amal Jyothi College of Engineering Kanjirappally, Kerala, India and Vimala College (Autonomous) Thrissur, Kerala, India to develop collaborative teaching, research and exchanges between students, teachers, researchers and staff. This is a legally non-binding agreement which outlines an intention to promote collaboration between the above-mentioned institutions. This document would be followed by a Memorandum of Agreement specifying the areas of collaboration and sharing which will have legal binding.

# Art. 2 Scope of cooperation

Generally speaking and within the limits of financial means of each institution, the cooperation will take the following form:





- To exchange information on research and educational programmes
- To exchange information on teaching, learning material and other literature relevant to their educational and research programmes
- To jointly propose and engage in research or training programmes sponsored by funding agencies
- To exchange, on a reciprocal basis, students at Doctoral levels for limited periods of time for purpose of education and /or research.

#### Art. 3 Duration

Initially the term shall be framed for a period of five years and the parties herein, upon mutual agreement, may extend the period from time to time.

#### **Art. 4 Termination**

This MoU, unless extended by the mutual written agreement of the parties, shall expire five year after the effective date specified in the opening paragraph

# Art. 5 Assignment

It is understood by the parties herein, this MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement or rights or obligations arising here under either wholly or in part to any third Party.

This MoU is executed in duplicate with each copy being an official version of the agreement and having equal legal validity.
