d. The Department of Physics, with all available expertise and facilities of UG and PG programme, can be utilized for our students.

e. The said services above by the company are requested without any legal obligation to the company and the MOU is for a period of 3 Years.

2. RESPONSIBILITIES OF VIMALA COLLEGE THRISSUR

- a. The college will select and decide the date for the training of the students with due consultation with **ATHUL ENERGY CONSULTANTS**.
- b. The college shall maintain a separate database of the students undertaking training and shall maintain all documents, papers, accounting records and other evidence pertaining to this MOU.
