M. Com:

1. Business Environment VPMCI01 :: Resolved to replace Module 5 with Environmental Studies including a brief introduction of Pollution Control Act, 1986, Environment Protection Act, 1986; Biological Diversity Act 2002, National Green Tribunal Act, 2010; Consumer Protection Act, 1986 and Right to Information Act, 2005.

2. Quantitative Techniques for Business Decisions VPM C1C02 :
Rearrange the modules / topics in the syllabus.

3. Accounting for Managerial Decisions VPM C1C03 :

a. Module 1 - Activity Based Costing to cover only an introduction on the topic.

b. Module 2 - Capital Investment Process is to be replaced with Fund Flow and Cash Flow Statements.

4. Organizational Theory and Behaviour VPM C1C05 :

a. Module 5 - to include the topic 'Change Agents'

5. Advanced Corporate Accounting VPM C2C07 :

a. Module 2 - The topic 'Treatment of Dividend' to be included before the topic 'Bonus Shares'

b. Module 4 - To include 'Investment Accounts' also

c. Module 5 - To include Social Responsibility Accounting

d. Remove from Module 4 Final Statement of Banking Companies stated in the proposed syllabus

The revised Module 5 will include Social Responsibility Accounting, HR Accounting, objectives - Methods of Valuation - advantages and disadvantages - Accounting for Price Level changes - methods, CPP, CCA and Hybrid

6. Business Communication VPM C2C08 : Resolved to remove from Module 5 the topic 'Physical exercises, yoga and meditation for personality development and to include 'Resume preparations and office etiquette.

- b. To change the last topic to Corporate Social Responsibility of business.

9. Research Methodology VPMC3C13 : Resolved to

- a. remove the topic Sample Design from Module 1
- b. remove the topic 'Sampling Theories'
- c. Include 'Case study' after the topic observation
- d. include only an introduction to the topics univariate, Bivariate and Multivariate methods.

10. Financial Management VPMC3E01 : Resolved to

- a. restructure Module 1 and include topics Risk and Return, Time value of Money of single amount, annuity and perpetuity - compounded value of Money - Future value of single amount, annuity.
- b. remove the topic 'International Financial Management' from the proposed syllabus and include 'Cost of Capital and capital budgeting - Cost of Capital: concepts and methods of computation - Capital budgeting decisions under risk and uncertainty and their evaluation using Statistical decision theory.
