1. Discussion on new syllabus for B.Com Dated 10.05.2017 introduced by University of Calicut for 2017 admission

After due deliberations, the following resolutions have been adopted :

1. The Board reviewed UC/PG Syllabi for Economics and no change was recommended
2. The Board reviewed UC/PG Syllabi for Commerce and following changes were suggested in the existing B.Com syllabus, on the basis of new University syllabus for 2017 admissions, on

which decisions to be taken by the new Board of Studies will be constituted in January 2018. No changes were recommended in the M.Com syllabus

For Admissions 2018-19 Batch

a. It was suggested, if the University Board of Studies permit,

i) to change the name of Income Tax and GST Course in the VI Semester to GST by removing the first module from the Income Tax and GST and club the same module with the fifth semester Income Tax Law and Accounts course, which is a change in the new university B.Com syllabus for 2017 admissions

ii) to change the name of Financial Derivatives to IFRS and add as separate course in the VI semester B.Com and to add financial Derivatives content with Fundamentals of Investment course which is in the V Semester

iii) It was also suggested, before implementing the changes, to conduct workshops for teachers and to outline the syllabus with the help of industry level experts.
