ORDER

As per the reference cited 1st above, the Principal, Vimala College, Thrissur has submitted an application for recognising the Department of Malayalam of the College as Research Centre of the University.

Considering the request, the Vice-Chancellor has been pleased to appoint Prof K D Bahuleyan, Member Syndicate (Convenor), Dr. Rosy T T, Associate Professor, Department of Malayalam, S H College, Chalakkudy (Subject Expert) and Director, Directorate of Research as members of the Research Recognition Committee to inspect and report on the facilities available in the Department of Malayalam, Vimala College, Thrissur to consider the application for recognising it as a Research Centre of the University vide reference cited 2nd above.

The Committee inspected the Centre and submitted the report vide reference 3rd above, which unanimously recommended for a reinspection, as the space for research scholars does not have sufficient infrastructure and suggested that the facilities should be upgraded.

The Principal has informed that they have arranged Spacious Research Room with all facilities and Adequate Furniture in the research centre, as recommended by the Research Recognition Committee, vide reference cited as 4th above.

Considering this, the Vice - Chancellor ordered for a re-inspection and the Committee inspected the Centre and submitted the report vide reference 5th above which unanimously recommended to grant recognition as Research Centre to Department of Malayalam, Vimala College, Thrissur, with a recommendation to consider the space for future expansion.

The matter has been placed before the Syndicate for consideration on the basis of the report of the Research Recognition Committee and as per the reference 6th above, the Syndicate at its meeting held on 05-11-2019, has resolved to grant recognition to the Department of Malayalam, Vimala College, Thrissur as Research Centre of the University vide item No. 2019.1093*, with the directions detailed in pre-para.

Sanction has been accorded by the Vice-Chancellor on 13-11-2019 to implement the decision of the Syndicate dated 05-11-2019 vide item No. 2019.1093*, to grant recognition to the Department of Malayalam, Vimala College, Thrissur as Research Centre of the University.

The provisional recognition is granted to the Department of Malayalam, Vimala College, Thrissur for a period of five years and permanent recognition will be granted only after reviewing the performance of the Centre at the end of the fifth year as per the Research Regulations of the University.
