**Memorandum of Understanding between Department of Zoology, Vimala College

And

Rosen Fisheries, Marathakkara, Thrissur

The memorandum of understanding (here in after referred to as MoU) is made on 30-10-2019 between Department of Zoology, Vimala College, Thrissur (here in after referred to as first party) and Rosen Fisheries, Marathakkara, Thrissur (here in after referred to as second party) for conducting Ability Enhancement Course (Audit course) for the 1st year M.Sc. Zoology students, student project of 2nd year M.Sc. Zoology and industry-academia interface programme including farm visit for Final year B.Sc Zoology students of Vimala College Thrissur. This MoU is signed by Dr.Sr.Beena Jose, Principal, Vimala College, Thrissur, representing the first party and Mr.C.D.Sebastian, Director, Rosen Fisheries, Marathakkara, Thrissur, representing the second party.

Whereas both parties have agreed to associate and carry out the Ability Enhancement Course (Audit course) on the topic '**Aquaculture techniques-Innovative trends**' for 1st year M.Sc. Zoology students, for conducting student project of 2nd year M.Sc. Zoology, organising industry-academia interface programme including farm visit for Final year B.Sc Zoology students of Vimala College, Thrissur with an overall objective of enhancing the knowledge, attitude, self employability and practices of the students. Now, both parties have agreed to enter into this MoU formulated as per the mutually agreed terms and conditions mentioned below.

1. To organize Ability Enhancement Course (Audit course) for the 1st year students of M.Sc. Zoology of Vimala College during Saturdays of every month at Rosen Fisheries, Marathakkara as per the timetable prepared jointly by both parties

2. The course content will be developed by the first party in consultation with the second party
3. The overall coordination of the programme will be done by the first party in consultation with the second party
4. The resource persons for handling the theory and practical classes will be identified and arranged by the second party
5. Examination at the end of the course will be conducted by the first party in consultation with the second party
6. Certificate for audit course (Non-credit course) will be issued jointly by both parties
7. 2nd year M.Sc. Zoology Students can carry out their student project in association with the second party
8. To organize farm visit for final year B.Sc Zoology students and second party will provide facilities for the visit
9. Students will pay the fees to second party which will be mutually decided by both parties
10. First party will send the students to Rosen Fisheries fish farm
11. The selection of the students will be done by the first party

Duration

Duration of Ability Enhancement Course (Audit course) for the 1st year M.Sc. Zoology, students will be of 6 months consisting of a total of 40 hrs spread over Saturdays of every month.

Duration of M.Sc project for 2nd year M.Sc students will be of 8 months as jointly planned by the project supervising teacher and the second party

Duration of Farm visit for Final year B.Sc Zoology students will be organized for one day in a year.
