Discussion on the various items in the Agenda of the meeting resulted in the following suggestions and recommendations:

Item 1: Confirmation of the minutes of the previous Board meeting held on 7 Oct 2020
The meeting minutes of the previous Board meeting was discussed and confirmed by the board.

Item 2: Recap of academic activities since the previous Board meeting

- Members appreciated the efforts taken by the department to conduct international webinar on Memoir Literature, Literary Fiesta conducted in memory of John Keats, National Webinar on MOOC and Add on courses in French and German and Trinity certificate course during the time of pandemic.

Item 3: Review of the syllabus of UG and PG programmes introduced in 2019

- The feedback of the students on the revised syllabi of 2019 was discussed. The UG English main students had reservations regarding their I Semester Core course, *Introducing Literature* which is a highly retrospective and reflective course and the UG Functional English students have reservations regarding the volume of the I Semester Complementary course, *Literatures in English*. However, effective teaching strategies are employed by teachers in charge of the respective courses to support and enhance the learning of the students.

Item 4: Any other discussion on academics

A few recommendations were put forth by the Board:

- The board recommended the initiation of new value-addition courses by the Department which would incorporate all the students of the College as its beneficiaries. This would help the Department and the College to meet the benchmark set for accreditations. The Dept will take necessary action regarding this suggestion.
- The board recommended introducing outreach initiatives that would be beneficial to the local community. Requirements in the immediate neighbourhood could be identified and services could be offered in the schools and other institutions and establishments in the locality.
- The Board enquired about the status of the Community College and suggested that the gadgets purchased for the Programme could be utilized to conduct online and offline courses/workshops for students within and outside college and to consider collaborative ventures with other institutions. However, apprehension about the practicality of such an offline course in the midst of pandemic was also raised.
- The board also pointed out the benefits of identifying catchment areas that require Basic English Course especially among housewives and children who are unable to afford privileged education and suggested that the Department could make use of its own resourceful and competent students for the same.
- In the current scenario of the pandemic as it is difficult for UG and PG students to do internships, the board suggested that the students could do an online course instead of the internship for course completion.

The Chairperson thanked the Board members for their valuable suggestions and their presence. Their co-operation throughout the Board meeting was specially mentioned with gratitude and the meeting concluded at 2.30 pm.

The major points and suggestions in the discussion were the following:

Agenda 1: Review of the implementation of syllabus since 2019
(UG and PG programme)

The board suggested to continue with the respective syllabi for 2019 admission batch and 2020 admission batch till both the batches complete the programmes

Agenda 2: Result analysis of previous end-semester examinations

The result of end semester examination of V semester BSc Mathematics was discussed and the members expressed their satisfaction on the conduct of offline examinations and the result which is 95.75%.

Agenda 3: Examination reforms for internal assessment

The board suggested to conduct individual viva online along with online internal examinations. Out of 50 marks, at least 15 marks for viva should be given. This would help the teacher to know whether the students are understanding and studying the concepts taught in online class.

Agenda 4:OBE- Mapping and achievement level

Though a number of softwares are available for mapping CO's and PSO's to PO of each programme, the board suggested that it is the duty of each teacher to know how far the outcomes of each course are attained by their students. This can be done using exit survey and improvement measures should be taken

Agenda 5: Evaluation of online classes, internships, online courses etc

Students should be encouraged to do academic internships and online courses. Most of the students have done online courses. All should be encouraged to do so

Agenda 6: Activities for the advanced learners

Advanced learners should be encouraged to study for and write competitive exams like JAM. They should be sent to higher level institutions for internships so that they can continue their higher studies there.

Agenda 7: Other academic activities of the department (Seminars, workshops, new courses (NEP) etc

The online seminars, workshops, intercollegiate competitions and Math Fest conducted by the department during this academic year and regularizing existing PG Course were discussed.

The board also suggested to start new interdepartmental courses like PG in Industrial Mathematics in association with Commerce and Economics departments;

Item 4: Evaluation of the add-on courses/value added courses

The board also recommended to continue the skill oriented value added courses.

Item 5: Review of the syllabus – Complementary Statistics (BSc Psychology)

The board discussed about the course code problem of II semester B.Sc. Psychology Complementary Statistics STA2C02 - Regression analysis and probability theory which is same as the course code of II semester B.Sc. Mathematics and Computer science Complementary Statistics STA2C02 - Probability theory and board suggested to report the same code problem to the Chairman of BOS of statistics, Calicut University.

Item 6: Use of non programmable scientific calculator in the examination

The board decided that the non programmable scientific calculator can be used in the examination and it is also mention in the question paper of the examination.

Sr Ani Davis, Chairperson of the BoS welcomed all members to the meeting. Sister congratulated Dr Binu P Chacko for being the Member of Faculty of Sciences, University of Calicut. She then presented the agenda of the meeting

1. Minutes of the previous BOS meeting and the action taken report on the resolutions made were presented and approved
2. The members discussed about the add on/value added courses to be implemented. Discussed about the prospects of Courses on Cloud Computing and Data Science and a course on Machine Learning . The Board resolved to recommend to offer value added course on Introduction to Machine Learning for the second year students.

3. The board approved to continue the syllabus of B.Sc Computer Science, B.Voc Web Technology, PG Diploma in Data Science and MSc Computer Science in the next year (2021-22) also.
4. Since there is no financial support from UGC for B.Voc next year onwards it should run in self financing mode. BOS suggested continuing the programme and suggested that rather than trying for equivalency for B.Voc, it is beneficial to get eligibility for admission to the MCA course.
5. The Board resolved to recommend offering the PG Diploma in Data Science Sanctioned by UGC Offline mode and the additional same course on online mode also as there is significant demand for the course.
6. BOS suggested conducting the offline lab sessions for the betterment of students.
7. Board suggested innovative teaching methods for practicals and hands-on sessions like Hacker rank (<https://www.hackerrank.com/>). Students can learn any programming language in hands on mode which will also help them for the practical sessions.
8. Board recommended to retain an Institute Industry Interaction cell in our college. BOS suggested to obtain tie up with Industry which will enhance student career opportunities. The board appreciated the department for conducting monthly programmes on “Industry Academia Interface” by Resource persons and Alumni from Industry background.

Discussions on the various items in the Agenda of the meeting resulted in the following suggestions and recommendations

It was followed by the discussion on the following Agenda items.

1. Discussion on Revision of existing syllabus
2. Discussion on New Certificate course for the next Academic Year
3. Discussion on “use of calculators in UG exams”
4. Any other matter that may arise

Major resolutions passed in the board are detailed as follows: -

1. DISCUSSION ON REVISION OF EXISTING SYLLABUS

Minor revisions were suggested and passed in the Board on the following papers:

BA Economics Syllabus 2019

Financial Economics (ECO6 B11) Core Course 11, Semester VI

- I. In the syllabus, it was resolved to omit Module V on “Derivative markets” found to be beyond the comprehending capacity of the undergraduates. In order to simplify the syllabus, it was also suggested to incorporate the following contents to include the module if needed as follows: An introduction to financial derivatives: Participants in the derivative market; Types and uses of derivatives; Advantages and disadvantages of derivatives; Forward Contracts, Futures Contract and Options.

MA Economics Syllabus 2019

Macroeconomics: Theories and Policies I (ECO1 C02), Core Course-II, Semester I

1. It was resolved to include “Patinkin’s Real Balance Effect” in Module I as it is a relevant topic in the content.

Indian Economy: Problems and Policies (ECO1 C03), Core Course-III,

Semester I

- I. It was resolved to omit topics related to economic planning in India in module 3(Planning and economic development-Objectives of planning- Techniques of planning, Achievements of planning- Bottom up and Step down approaches in planning- Evaluation of Five Year Plans), since it was found to be a repetition of the Indian Economy syllabus studied at the UG level.

- II. It was resolved to rename Module 3 as “Economic Planning and Budget analysis” giving focus on topics related to Budget, role, analysis of Union and State budget and welfare schemes of current budgets along with existing topics NITI Aayog and its Vision Documents.

Macroeconomics: Theories and Policies I (ECO2 C06), Core Course-VI, Semester II

- I. It was resolved to include “Classical Dichotomy” in Module1 as it was found to be a vital topic to be covered before the introduction of Keynesian General Theory.
- II. It was resolved to omit “Rational Expectations Hypothesis” and “NAIRU” in modules 3 and 4 respectively in accordance to the repetition of the topics in Course II of Semester I.

Basic Econometrics (ECO3 C11), Core Course-XII, Semester III

- I. It was resolved to replace the topics Regression through the origin-Functional forms of regression models, log-log, log-lin, lin-log and reciprocal models from module 4 to module 1 which deals with Simple Linear Regression model in detail.
- II. It was resolved to include topics such as types of specification errors, Detection and consequences-RESET-Errors of measurement-Consequences, remedies in module 3 which deals with econometric problems.
- III. It was resolved to make changes in the title of module 4 omitting “Extension of Two Variables” and replacing it to “Dummy Variable Regression Model”. It was recommended that such modification would confine the module to the understanding of Dummy Variables.
- IV. It was resolved to delete module 5 on “Model Specification and Diagnostic Testing” and include topics such as Linear probability model - Logit Model -Probit Model hence changing the title as “Qualitative response regression models”
- V. It was resolved to include Tobit model to module 5 so that the content would be intact.

Advanced Econometrics (ECO4 E01), Elective Course Semester IV

- I. It was resolved to omit Module 1 since it is included in the course “Basic Econometrics” of Semester III

- II. It was resolved to rename Module 2 as Module 1 under the title “Dynamic Econometric Models” omitting the topics of panel data regression from it.
- III. It was resolved to include “Panel Data Regression Models” as Module 3 by adding the topic ‘Constant Coefficient Model’ along with the existing topics.
- IV. It was resolved to exclude “Time Series Econometrics” from the title of Module 4 making it as “Instrumental Variables Regression”. Also the topics under “Time Series Econometrics” are excluded from Module 4
- V. It was resolved to rename Module 5 as “Time Series Econometrics” by adding the topics excluded from Module IV along with the existing topics of Modelling Stochastic Processes.

Research Methodology and Computer Applications (ECO4 E10), Elective Course, Semester-IV

- I. It was resolved to reframe the syllabus on Research Methodology for clarity and better understanding of concepts.
- II. It was resolved to make changes in Module 1 by incorporating topics from module 2 such as Research design and methods- Exploratory, diagnostic and experimental studies- Deductive and inductive method- Static and dynamic method- Historical and dialectical method- Case study method- Interdisciplinary research.
- III. It was resolved to add the topics of Concept of Falsification. Relating hunch, hypothesis and thesis, mixed methods study in Research – features- types-uses and limitations in Module 1 due to the relevance of the topics.
- IV. It was resolved to include a new Module 2 on Review of Literature including the topics Functions of Literature Review – Types of Review – Narrative Vs Systematic Review – Meta Analysis – Process of Conducting Literature review-Deriving hypotheses from the literature review- MLA and APA style in format and Citation- ethics in research and plagiarism.
- V. It was resolved to rename the title of Module 3 as “Sampling and Data Collection”. The topics Sampling Methods- Random, stratified, multistage, systematic, cluster, quota and judgment samples are brought from Module 4 to Module 3. Some new topics like Panel Data, CAPI method in field survey, Introduction to Important secondary data sources in India - Quantitative and qualitative data are added to Module 3

- VI. It was resolved to rename Module 4 as “Data Analysis and Report Writing” by including new topics such as Data cleaning, coding and processing along with the existing topics..
- VII. It was resolved to delete the topics, presentation of graphs – Line, subdivided, multiple, pie graphs from Module 5 and add the topic Introduction of Statistical Software (freely available such as R) in to Module 5.

2. DISCUSSION ON NEW CERTIFICATE COURSE FOR THE NEXT ACADEMIC YEAR

- I. It was resolved to introduce the new certificate course on “Participatory Local Governance”. The need of the course was stressed and was appreciated as an ideal course, if KILA consented to the conduct of the course.

3. DISCUSSION ON “USE OF CALCULATORS IN UG AND PG EXAMS”

- I. It was resolved to include the following instructions for using calculators by students in the introductory part of the UG and PG syllabus for Economics.

Programmable or scientific calculators are not permitted for UG and PG examinations. Mathematical table by Clark and statistical table (logarithms antilogarithms mathematical & statistical tables) alone will be permitted to be used during examinations”.

4. ANY OTHER MATTER THAT MAY ARISE

- I. The result analysis of S5 UG students was presented and the board members reviewed the same.
- II. The consolidated report of course evaluation done by the PG students was presented and the board members reviewed the same.

- III. It was resolved to include more activities for advanced learners such as internships and interactions with faculties/scholars of premier institutes.

Recommendations**Item1:**

The Board has confirmed the minutes of the previous BoS.

Since the newly introduced PG syllabus has been transacted for one batch the board has suggested to conduct a workshop for all the stakeholders to gather the necessary inputs before revising the PG 2019 admission syllabus. As the parent university is doing the revision of both UG and PG syllabus the board has suggested to wait for the releasing of the revised syllabus by the university.

Item 2:

The board reviewed the evaluation methods for the courses and programme and appreciated the automated feedback mechanisms in the college.

Item3:

The Board has placed high appreciation for the efforts of IQAC and CoE office of the College especially in designing a modus operandi for OBE- the workshops for the preparation of PO, PSOs, COs, training for the preparation of question banks based on taxonomy, designing a customized software for mapping the achievement with outcomes.

Item 4:

I. The board has evaluated the effectiveness of online classes and recommended:

1. Blended learning for the academic transactions in the coming years.
2. Uploading of recorded lectures for those students who have accessibility issues.
3. Digitally empowered student-teacher community is noted as a positive change due to this pedagogical shift therefore more software and online platforms can be incorporated in the teaching-learning process.
